INSTRUCTIONS FOR FILING A

THIRD PARTY COMPLAINT / MOTION FOR LEGAL CUSTODY

1. Completely fill out the following:

(A) Complaint / Motion for Legal Custody

(B) Motion for Temporary Custody (if requested);

(C) Parenting Proceeding Affidavit (Uniform Domestic Relations Form Affidavits);

(D) Request for Service (Uniform Juvenile Form 10) <u>or</u> Waiver of Service (Uniform Juvenile Form 9); and

(E) Juvenile Family Information Sheet.

- 2. If the case is an **<u>initial</u>** juvenile complaint involving custody, you <u>**must attach**</u> a copy of the child(ren)'s birth certificate or other evidence of parentage.
- 3. All parties must be served with your Complaint / Motion. Complete addresses must be included on the Instructions for Service Form. The hearing may not go forward unless the parties have received proper notice. You will be notified of your hearing by mail.
- 4. You must be prepared to pay the filing fee. Fees must be paid by cash, money order or credit / debit card.

(A) New complaints - \$140.00

- (B) Motions on existing case \$100.00
- 5. If a parent cannot be located, a service by publication or posting must be completed as required by the Rules of Juvenile Procedure.
